Since many of you are wondering, and clarity allows truth to be expressed, I'm going to share with you the result of research, analysis, first-hand testimonies and feelings that make the pieces of the puzzle fit together and see more clearly what's going on in the disclosure right now.

- The first strong step was when Kevin made his FB post about the persistence of current abductions by the Greys and said that gurus shouldn't be followed like sheep. My impression and that of many others reading his post was deep violence and anger directed towards Elena Danaan. By this post he clearly accused her of being a guru and those who follow her work and what she transmits of being sheep.

I learned later that Elena didn't know anything and was surprised by the post, learning it herself through someone else. To this post she commented her disagreement, first politely, then was attacked by Kevin in her answers.

Before publishing this aggressive, accusatory post of manipulation, did Kevin contact Elena to discuss with her about their difference of views on abductions? Nope. I got confirmation that no private chats were exchanged to clear things up, Kevin then blamed Elena for blocking him on FB without bothering to talk to him.

- On another note: Kevin knows JC and Melanie very well. JC has always introduced him in his movies as his best friend.

Kevin's post about the GSIC 2024 Westminster Skywatch:

- His post stated that there has never been any flyby of the GFW or TR3B ships. In this post, he asserted/demonstrated that what 1000 people, including myself, had seen with their physical eyes were actually migratory birds. In addition to the affirmations/slander, the tone vibrated once again with violent anger. Of course, we were many to react with force having seen with our own eyes the vessels and not understanding why such aggression in this matter. I can confirm with certainty that I have seen a TR3B and not 3 geese in the shape of a triangle. I saw with my own eyes the lights of the TR3B and its torsion field. I also saw birds. A very good friend of mine saw the GFW vessels and is very clear with what she saw and felt. Both ship types were there. Some have apparently only seen the birds, some have seen the birds and the ships, some have seen ships and not the birds and some did not know anymore, after Kevin's post that was sowing confusion. (For a precise study and to arrive closer to the truth, Kevin should have interviewed the 1000 people present and not have limited himself to a few.)

In the light of Kevin's violent defamation, Dani Henderson responded with the same strength to defend the honor and integrity of her GSIC event. Kevin turned this against Dani and Elena.

The moment I saw Kevin's post about GSIC and before even seeing some comments, I felt a vibrating frequency of a great power that Melanie and Jean-Charles were supporting Kevin in this process. The frequency was truly powerful and very clear. This even made me uncomfortable. Incidentally, I told several friends about it that evening, and the days that followed to see things clearly, it bothered me so much. The doubt

persisted in me despite the clarity of the perceived frequency and other more personal and private pieces of the puzzle that fit in that direction.

What I learned later that confirmed my perception is that the attacks of Kevin Luengo (Grey and Migrating Birds) began 4 days after Dani Henderson (GSIC organizer) told JC and Melanie that she no longer wanted them participating in future GSICs. Kevin, JC, and Melanie were linked in this story.

Following these episodes, Kevin opened a public Telegram account to gather people who share the same views as him about Elena and Dani. I share here what I find to be strong clues of the double game played by Melanie and Jean-Charles: it has been reported to me by several people that these fake Telegram accounts (see the screenshots below) defaming Elena in Kevin's group in order to sow the division are those from Melanie and JC. What about people who hide under alias to turn people against Elena and support Kevin's threats, when they were supposed to form the core of disclosure? Isn't it about sowing division in the midst of disclosure?




I let you do your research and draw your own conclusions. But the truth must be told for more clarity and put an end to the confusion.







