Question:

Dear @Ninmah777 did any of your contacts confirm the presence of a space ark under Sedona?

Answer by Elena Danaan:

No

Question:

Dear Elena when I asked you if you had confirmations from your "upstairs" contacts about the Sedona "ark" and you said "no", may I ask if there is also no ark under Nazca (Peru)?

Answer by Elena Danaan:

[Name] I haven't been informed by my off-world contacts of any ark in these locations.

Answer by Elena Danaan:
